The District of Columbia Small Business Resource Center (SBRC) is a one-stop-shop where help is provided to assist in starting, growing and strengthening businesses.

The SBRC's primary function is to provide FREE one-on-one assistance and group workshops to future and current business owners as they navigate District's regulatory processes.

ONE-ON-ONE SESSIONS

SBRC COUNSELING SESSIONS: HOW TO START A BUSINESS

DCRA Small Business Resource Center (SBRC) staff will provide one-on-one assistance with navigating through the regulatory process via phone or video conference. You will gain in-depth knowledge of registering with corporations (i.e. Limited Liability Company, Corporations, Non-Profit, etc.) and with the basic steps of obtaining a business license. Additionally, you will receive assistance with the zoning application process (i.e. Certificate of Occupancy and/or Home Occupancy Permit). This opportunity is geared towards future and current business owners looking to conduct business in the District of Columbia.

HOW TO OBTAIN A CERTIFIED BUSINESS ENTERPRISE (CBE) CERTIFICATION

COUNSELING SESSION WITH THE DC SMALL BUSINESS DEVELOPMENT CENTER (DCSBDC)

Small Business Development Center (SBDC) will provide assistance on the fundamentals of business planning, market research and analysis, capitalization, and legal structures. Technical assistance and services are also available to help pre-ventures and start-up companies navigate the plan review and business licensing processes, and other capacity building issues.



COUNSELING SESSION WITH THE DC BAR PRO BONO CENTER

During this session, counselors from the DC Bar Pro Bono Center will answer corporate law questions, including entity formation and legal structures, business licensing and certification.

COUNSELING SESSION WITH THE OFFICE OF TAX AND REVENUE

During this session, representatives from the Office of Tax and Revenue (OTR) will provide assistance with navigating the DC tax registration process. Representatives from OTR will provide you with a better understanding of following:

- Mytax.dc.gov Registration
- FR 500 Application Process
- Non-Profit Tax Registration
- Clean and Hands Certification

ALL THINGS NON-PROFIT

HOW TO OBTAIN YOUR MADE IN DC CERTIFICATION

DSLBD will provide an overview of the Made in DC program, the application process and the benefits to your business. Utilize the Made in DC Program to promote your products across the District and provide business support.
