


High-Level Findings:

*Note – use Word’s zoom feature to zoom into image in right-hand column

- While there were occupants of 2253 Mt. View Place, SE from around 1970 - 1990, no occupants were listed at 1220 Maple View Place, SE in the directories accessible and listed below.
- Around 1995, 1220 MVP SE & 2253 Mt View Place SE started to become cross-listed as the same address in the directory.
- It appears that 1220 MVP SE/2253 Mt. View Place SE was completely vacant starting in the mid-90s with no occupants listed.
- The Spring Street address didn't exist in the directories during this time frame.
